

## Bicycle Rental Agreement and Release of Liability

Now, therefore, for and in consideration of the mutual covenants contained in this agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of this rental agreement shall commence on \_\_\_\_\_ (**date and time**). *Renter* agrees to pay **Bighead Cycling** the sum of \$\_\_\_\_\_, in advance, as rent.
2. *Renter* shall use *Bicycle* in a careful and proper manner, shall comply with all applicable laws and regulations, and shall maintain the *Bicycle* in good repair and condition. *Renter* assumes all risks of loss and damage to the *Bicycle* from any cause whatsoever and agrees that the *Bicycle* will be returned to **Bighead Cycling** in the same appearance and condition as when received, ordinary wear and tear excepted.
3. *Renter* acknowledges that cycling is an inherently dangerous sport in which *Renter* participates at his/her own risk; and further acknowledges that **Bighead Cycling** will not rent a *Bicycle* to me unless I sign this agreement which includes a waiver, release and assumption of risk agreement.
4. The undersigned does hereby agree to, covenant to, and represent the following:
  - a. I, on behalf of myself, my heirs, assignees and personal representatives, do release and forever discharge **Bighead Cycling**, its employees, officers, and agents (all of which are hereinafter jointly and severally referred to as **Released Parties**) from any and all liability, claim, loss, cost or expense, arising directly or indirectly from, or attributable in any legal way to, any negligence, action or omission to act of **Released Parties** that results from my rental of said *Bicycle*.
  - b. I currently have no known physical or mental condition that would impair my capacity to safely use said *Bicycle* as intended or expected except for (*specify*) \_\_\_\_\_ *If none write NONE.*
